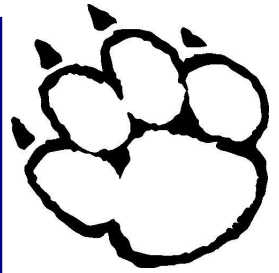


Extended Wildcat Hours



- Before School Extended Hours is 6:00 a.m. - 7:00 a.m.
- After School Extended Hours is 3:00 p.m. - 6:00 p.m. on regular school days
- After School Extended Hours is 1:00 - 6:00 p.m. on early dismissal days

All students on campus after 3:00 p.m. (1:00 p.m. on early dismissal days) who are not riding the bus, enrolled in an after school program, or waiting in parent pick up will be directed to after school extended hours and assessed a fee. All fees will begin to incur at 3:30 p.m. (1:30 p.m. on early dismissal days)

There are 2 payment options to fit your schedule. Please choose one of the options below, as this will be your scheduled payment plan for the school year.

(Please note: There is no switching between options throughout the school year.)

Option 1: Flat Rate

A Flat Rate will be charged each week the student attends before and/or after school extended hours. (the same amount is charged each week regardless how often the program is utilized.)

Before School:

\$35 per week for 1st child
\$30 per week for each sibling

After School:

\$50 per week for 1st child
\$40 per week for each sibling

Before & After School:

\$75 per week for 1st child
\$60 per week for each sibling

Option 2: Hourly Rate

A Hourly Rate of \$10 per hour will be charged for the time the student attends the program.

All “drop ins” will be charged on an hourly rate.

****If a parent misses parent pick up, the child will be sent to after school extended hours and will be charged the hourly rate, with fees incurring at 3:30 p.m. (1:30 p.m. on early dismissal days)**

ATTENTION!

***For both payment options, a late fee of \$5.00 per minute will be charged after 6:00 p.m. on regular school days and on early dismissal days (according to site clock).**

****Police will be called at 6:30 p.m. if the child has not been picked up.**

- Payments must be made on the Friday prior to the week of participation and will be accepted on a weekly basis. **If payments are not received prior to attendance, the payment must be received upon receipt of the weekly invoice.**
- **Drop in payments must be made the same week of the “drop in.”**
- Late Payment Fees - A **\$15 late fee** may be charged per month on any unpaid balance.
- Statements are provided monthly for the sole purpose of showing payments toward your account. **You are responsible for payment for the services prior to the beginning of each week. Do not wait to be invoiced.** Any balance that is over 90 days past due will be sent to collections.

Any and all past due invoices must be PAID IN FULL to be eligible for the program. Noah Webster School has the right to remove your child from any school program if balances are not brought current on a weekly basis.
