A public meeting of the Board of Directors (the "Board") of the Noah Webster Schools-Pima, an Arizona non-profit corporation (the "Corporation" or the "School"), was held at the school's Corporate Conference Room at 5399 N. Pima Rd, Scottsdale, Arizona at 4:30 p.m. A quorum being present, and the meeting having been duly noticed and called, the meeting was called to order.

1. Call to Order
2. Approve the Minutes of the October 17, 2018 Board Meeting

A motion was made by Director Pennington to approve the minutes for the meeting as presented. Director R. Miller seconded the motion. Director Tomasson, Director R. Miller, Director S. Miller and Director Pennington all voted in favor of approving the minutes as presented.

3. Special Education Report

Ms. Marty Spitz, Special Education Director of the school, gave a presentation on Special Education at Noah Webster Schools. She provided the Board with information on the Child Find Process, which included the referral protocol and the data collection that takes place. She reviewed CST (Child Study Team) procedures for early intervention prior to Special Education referral and its related services and schedule. The Special Education Process, referral cycle and the related myths were all addressed. The Board also received information on IEPs, 504s, teacher input, accommodations and ADE compliance.

4. Standard & Poors' Annual Review

Sharon Miller presented the Board with the completed S & P Global Charter School Information Request Form for 2018. Director Miller asked the Board to pay special attention to the section detailing the additional costs of Special Education Services as well as Transportation and the Free & Reduced Lunch program. Many charter schools do not offer any of these services and Director Miller felt it necessary to point this out to S & P. In addition to the completed form, Director Miller informed the Board that several other informational reports were sent to S & P. She indicated that a phone interview would be set up shortly for additional questions & information that the analyst may want to review.

5. FY18 Annual Financial Audit

Ms. Dry provided the Board with copies of the FY18 Annual Financial Audit completed by Fester & Chapman, P.C. They received:
